Kerrville-Schreiner Park is a stunning 517-acre recreation and camping park situated along the Guadalupe River. State Highway 173 divides the park into two sections: the Hillside (the larger section) and the Riverside (the smaller section, located on the Guadalupe River). The Park is home to an abundance of wildlife, including whitetail and black buck antelope, axis deer, rabbits, fox, birds, butterflies, and more. The Park includes over 12 miles of hiking and biking trails. All campsites include a picnic table, a campfire fire ring with grill, and a maximum occupancy of 8 people. Seasonal kayaking, canoeing, and swimming/fishing with easy access to the Guadalupe River. Leashed pets are welcome but prohibited in all buildings, facilities, and the day-use area along the river.
