SUMMARY STATEMENT

Councilmember Stephen Fine directed that this item be placed on the agenda at the regular City Council meeting of May 10, 2016.

Upon canvassing the election results from the May 7, 2016, election Ms. Bonnie White will become Kerrville's next mayor. She is currently the Place Two councilmember, which will be vacated for the remaining year of her term. **Section 2.04 Vacancies** of the City of Kerrville Charter states that the City Council shall appoint a qualified elector to fill a vacancy within thirty (30) days after a vacancy occurs. This appointment will be for the remainder of the Place Two term. An appointment to Place 2 must be made by the City Council no later than June 16.

This item pertains solely to discussion and action regarding the appointment process.

RECOMMENDED ACTION

This is a policy decision of the City Council and city staff has no recommendation.
