1. APPROVE MINUTES:

1C. Chris Daniel has been involved in working with addiction and recovery for a number of years. We have a family foundation that he is in charge of. There are a number of private foundations that help with addiction and recovery where there are limited qualifications and are required to give the funding away. Sometimes they find themselves in a crunch because they need to distribute the funding. Private foundation money is so much easier to obtain and utilize than government funding. They are operated by private citizens and not civil servants. He has learned that services are provided to people and they don't change people or behaviors. Private charitable groups come into the relationship with them to make a difference. They are able to collaborate and investigate ways to serve others and be agents of change.

2. STEVE PAUTLER

2A. He was not able to be here this meeting, but did send an update on the training event. Members reported that it was well attended and it was a good presentation/training. The trainers spoke specifically about the rural areas which was helpful for our area. There was a concern raised by Claudia Richner that the numbers of individuals treated with NARCAN were not accurate in reporting because it is all based on self-reporting.
