Aquatics Feasibility Study: Community presentation to EIC and Parks Board postponed due to pandemic, but will likely be rescheduled later this Summer.

Olympic Drive Infrastructure Extension: Sidewalk work completed near Singing Wind. Utility relocations are ensuing.

Legion Lift Station: Pumps being tested. Near substantial completion.

Guadalupe River Utility Crossing: City successful in receiving additional grant funds from TWDB for \$500,000 (\$1.5 million total). Plans to bid the project in late Summer.

Thompson/Spur 98 Infrastructure Extension: Project is close to completion. Liftstation work still underway.

ArcadiaLive Theater: Work is progressing and their plan is to be open in some capacity the first part of July.

KERV Airport Improvements: The Airport is working with TxDOT on the design effort for the T-Hanger project, and the subsequent Box Hanger project. The demolition of the Horseshoe building is being coordinated with the FAA.

Downtown Streetscape/Parking Garage: to be discussed later in agenda.

**SUMMARY STATEMENT:**

EIC received sales tax of \$319K in May 2020. This payment represents tax collected on sales in March. Since we are closely watching sales tax, I have also included June sales tax collections in the Sales Tax Revenue Analysis shown on slide 4 of the attached presentation.

Sales tax in June (April sales) is significantly better than originally estimated. Because this sales tax represents sales in April, when many businesses were completely closed, we expected June sales tax to be our lowest month. Instead, June sales tax was 7% MORE than June 2019. At this point, we only have summary level information about this number. We know that it does not contain any unusual amounts related to audit adjustments or out of period payments. We have requested detail by taxpayer from the Comptroller and will have more information on what is driving the increase after that is received.

Due to continued high levels of unemployment and government stimulus money that may be ending soon, it is not safe to assume that June's sales tax performance will continue. However, it does appear that Kerrville is not going to see the extreme downturn that was originally feared.

Based on the new data, we have revised our COVID-19 projection as follows:

July (May sales): 10% less than budget

August (June sales): 10% less than budget

September (July sales): 10% less than budget

October – March: 10% less than prior year

Using these new assumptions, sales tax revenue is expected to end the year approximately \$76K lower than budget.

On the expense side, EIC made regular monthly payments for administrative and debt service commitments and an initial payment of \$8,623 related to the Doyle School project. In addition, EIC made a quarterly payment to KEDC. The quarterly payment amount has been renegotiated from \$62.5K to \$47.5K.

Following this activity, EIC ended May with a cash balance of \$2,065,446. The cash flow forecast on slide 3 has been modified with the previously mentioned COVID-19 assumptions and actual sales tax through June. With these changes and updated project payment timing, EIC's cash balance is expected to vary between \$2.1 and \$2.3 million. Note that this cash flow forecast does not include payments for projects currently being discussed, but without a funding agreement.

EIC's funds are invested in TexPool, a completely liquid municipal pool account that is currently earning 0.56%.

EIC's FY2021 budget will be discussed in next month's meeting.
