The topics revolved around the definition of homelessness, a database to provide services to homeless individuals, how to assist, how to gather data and information, and what can Kerrville do to meet the needs. Dawn reported that in Kendall County it was especially powerful when the Sheriff shared the names of individuals who were Boerne graduates that are now homeless. Having individuals from our own community homeless makes it even more of a community problem that must be addressed.

5B. Sex, Drug Related Trafficking in Local Area- Claudia reported that the State of Texas is coming up with an assessment to determine whether or not an individual is being trafficked. She went to a recent training and will be providing updates. The Hill Country Crisis Council and MercyGates are working together to conduct information sessions and/or trainings.

6A. International Overdose Awareness Day Event: Night of Remembrance is scheduled on Saturday, August 31st.
