**A RESOLUTION CANVASSING THE RETURNS AND
DECLARING THE RESULTS OF THE NOVEMBER 3, 2020, CITY
GENERAL ELECTION**

WHEREAS, the City of Kerrville, Texas, held its general election on the 3rd day of November 2020, for the purpose of electing Mayor, Councilmember Place Three, and Councilmember Place Four, each to serve the remainder of a two-year term; and

WHEREAS, such election, originally scheduled for May 2, 2020, was rescheduled until the November date due to the novel coronavirus (COVID-19) and under the authority of a proclamation issued by the Governor of Texas issued on March 18, 2020; and

WHEREAS, it is found and determined that said election was held in accordance with the authorized procedures; that notice of the election was duly given in the form, manner, and time required by law; and that said election was in all respects legally held and conducted in accordance with the applicable laws of the State of Texas; and

WHEREAS, it is necessary and legally required for the City Council to canvass the returns of this election and to declare the official results;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF KERRVILLE, KERR COUNTY, TEXAS:**

SECTION ONE. The statements and findings provided above are adopted.

SECTION TWO. The official tally, as presented by the election judge and shown in Exhibit A is accepted and approved.

CONSIDERANDO que la Ciudad de Kerrville, Texas, celebró su elección general el 3 de noviembre de 2020, con el propósito de elegir al Alcalde, el Concejal Lugar Tres y el Concejal Lugar Cuatro, cada uno para servir el resto de un período de dos años;

CONSIDERANDO que dicha elección, originalmente programada para el 2 de mayo de 2020, fue reprogramada hasta la fecha de noviembre debido al nuevo coronavirus (COVID-19) y bajo la autoridad de una proclamación emitida por el Gobernador de Texas emitida el 18 de marzo de 2020;
