SUMMARY STATEMENT:

EIC received sales tax of \$311,718 in October 2020, which is 5.6% higher than October 2019. This payment represents tax collected on sales in August. Sales tax continues to outperform budget, despite the COVID-19 pandemic. Sales tax detail for October showed strength in the City's two largest categories, retail and manufacturing. Increases in the retail category were led by home improvement, big box stores and online retailers. This increase is even more impressive because, due to a timing issue with the Comptroller, we did not receive payment from one of the City's largest retailers in October. Instead, we received two months of payments from that retailer in November. November's sales tax payment (September sales), which will be received on Monday, November 16th, was 25% more than November 2019. A portion of that increase is due to the double payment previously discussed. However, after adjusting for the double payment, sales tax is still up 18%. We will provide further analysis to EIC regarding the increase after we receive detail

information by payor from the Comptroller.

On the expense side, EIC paid \$8,797 for Doyle School architect fees and engineering fees, \$49,375 in a quarterly payment to KEDC, and regular monthly payments for administrative and debt service commitments. Following this activity, EIC ended September with a cash balance of \$2,543,335. Looking ahead, the cash flow forecast shows cash balances ranging from \$2.3 million to \$3.1 million over the next year. EIC's funds are invested in TexPool, a completely liquid municipal pool account that is currently earning 0.18%.

SUMMARY STATEMENT:

EIC budgets for projects with signed funding agreements in place. During the year, EIC considers and may approve additional funding agreements that were not part of the original budget. In addition, City Council also approves any EIC funding agreements. Even though the funding agreements have been approved by EIC and City Council, separate action must be taken to formally amend the budget so that project expenditures can be shown as budgeted.

SUMMARY STATEMENT:

In September 2020, the City borrowed \$1 million from KPUB to help fund incentives for Killdeer Mountain Manufacturing. EIC has agreed to fund the debt service for this loan. The loan is structured as an interest only loan for 4 years, with a balloon payment of \$1 million due in 2024 and voluntary prepayments allowed at any time. Given better than expected sales tax results, extremely low interest rates on invested funds, and projected cash balances of \$2.3 million or more over the coming year, this item calls for EIC to discuss and consider action on loan prepayment options.
