- i. Thomas Hurt provided a summary of the Warrants Clinic and stated that attorneys were willing to make the Warrants Clinic happen for Kerr County.


He would follow-up with possible dates and sites for the event with the KRCC to keep up informed.

4. **PUBLIC HEALTH TASK FORCE REPORT OUT:** Chief Maloney provided an update on the results of the Public Health Task Force. It was determined that Kerrville has plenty of agencies and services yet lacks the systematic referral and awareness tools to assist individuals in navigating all of the services efficiently and effectively, therefore, it was determined that a Navigating Coordinator is needed to act as the liaison for all agencies to assist in referrals and system navigator. However, it was unclear what agency would employ a navigator or when one would come aboard to start the position.
5. **Discuss Christmas Luncheon Workshop – Dr. Kendall Young 5B. 2022 Goals for KRCC** - Dr. Young discussed the idea of having a December luncheon inviting all Sober Home Owners or managers to get an idea of the issues, problems, and roadblocks currently affecting individuals in the recovery community. It would be an effort to gather information and data to help focus efforts and resources to the individuals who need it most based on accurate input. Joseph Duprie volunteered to compile a list of current Sober Home Owners and Managers for Dr. Young to send invitations to the collaborative lunch. The lunch would take place during the week of Dec. 13th - 17th and not on a Saturday or Sunday. The lunch and collaboration would also serve as a way to gain a better understanding of long-term needs in the recovery community which would inform the direction for services that KRCC could provide in the way of information, education, events, or resources for the coming year to meet the needs of those in recovery or in need of services.
