4. CONSIDERATION AND POSSIBLE ACTION

4A. Parks, Recreation, and Open Space Master Plan Update

Malcolm Matthews presented a draft Parks, Recreation, and Open Space Master Plan document. All projects in the document were identified by the public, city staff, Parks and Recreation Board Steering Committee, and City Council for inclusion in this ten year plan. All have been listed under one of the Guiding Principles, relevant categories originally identified in Kerrville 2050.

The list of capital improvement projects below is placed as highest priority projects, and were finalized through public input meetings / surveys, the Parks and Recreation Board Steering Committee, the Kerrville City Council, and the Kerrville Parks and Recreation Department staff:

1. Singing Wind Park
2. Olympic Pool
3. Kerrville-Schreiner Park
4. Louise Hays Park
5. Miscellaneous Park Improvements
6. River Trail and other Hike / Bike Trails
7. Scott Schreiner Golf Course
8. Guadalupe River / Riparian Areas / Nimitz Lake
9. Dog Park

Consideration of the board to accept the draft as submitted. Erik Silvius motioned to accept draft as presented; the motion was seconded by David Bartels and passed 5-0.

The draft master plan will be presented and reviewed by the City Council at their workshop scheduled for April 19th. Once reviewed the document will be scheduled for adoption by resolution at the April 26, 2022 City Council meeting.
