2. CONSENT AGENDA

3A. Election of Officers

Mr. Willis volunteered for position of chair. Ms. Fiedler moved to accept Mr. Willis as chair; motion was seconded by Ms. Ebert and passed 7-0.

Ms. Egelston volunteered to act as vice-chair. Ms. Fiedler moved to accept Ms. Egelston as vice-chair; motion was seconded by Ms. Massey and passed 7-0.

Mr. Willis continued the meeting as new chair.

3B. Mobile Food Units in Right-of-Way

Mr. Melander discussed mobile food units in the right-of-way, discussing recommendations for needed permits and various requirements. The current code does not allow mobile food units in the right-of-way in the downtown arts and cultural district so this would allow more accessibility in the downtown area.

Ms. Fiedler questioned if there is a limit on how many MFU could be in downtown. Ms. Massey asked if this would be for events only. Mr. Melander stated the permit would only be for 36 to 48 hours. Each permit would be on a case by case basis.

Staff will take Board's input and bring this item back to the Board before proceeding to City Council.
