**RESOLUTION NO. 09-2024**

**A RESOLUTION CANVASSING THE RETURNS AND  
DECLARING THE RESULTS OF THE MAY 4, 2024, CITY  
GENERAL ELECTION**

**WHEREAS**, the City of Kerrville, Texas, held its general election on the 1<sup>st</sup> Saturday of May 2024 (May 4, 2024), for the purpose of electing a Mayor, Councilmember Place Three, and Councilmember Place Four, each to serve a two-year term; and

**WHEREAS**, it is found and determined that said election was held in accordance with the authorized procedures; that notice of the election was duly given in the form, manner, and time required by law; and that said election was in all respects legally held and conducted in accordance with the applicable laws of the State of Texas; and

**WHEREAS**, it is necessary and legally required for the City Council to canvass the returns of this election and to declare the results;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
THE CITY OF KERRVILLE, KERR COUNTY, TEXAS:**

**SECTION ONE.** The statements and findings provided above are adopted.

**SECTION TWO.** The cumulative results report, as submitted by the election judge and shown in **Exhibit A**, is accepted and approved.

**SECTION THREE.** From the returns duly and legally made, there were 4,551 valid legal voters and each of the candidates in the election received the following votes:
