**Kerrville, Texas (Sept. 23, 2024)** – Starting Oct. 1, 2024, the City of Kerrville will begin charging a three-percent fee on all credit card transactions. This includes purchases that are completed in person, over the phone, or online.

This new fee is due to the rising costs associated with credit card transactions.

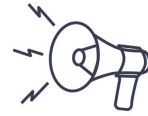
