**3. SACADA RURAL COMMUNITIES' OPIOID RESPONSE TEAM**

Phil reported that Naloxone dispensers have been placed and filled at Fog House and Fog Daddy's. Fog Daddy's has already been refilled once. There is also a dispenser at the exit of the Kendall County jail, and two are planned to be placed at BCFS. Phil did training at CASA ad litem meeting which was attended by about 100 folks including lawyers and judges. Additional Naloxone grants have been secured for 2025

**4. HCCADA UPDATE**

Abby submitted a package from a sober home who wanted to be included in the KRCC resource guide. Delayne said she would reach-out to the home owner to see if she could help them in any way. There is a coding and billing training session scheduled for April 14 and 16. Abby provided a Recovery Community Needs Survey that we can use as a starting point for the luncheon being planned for May.

Chief Maloney reported that the meeting was again cancelled.

Substance Abuse at MHDD is the primary supporting agency. The US Army reserve wants to do a Fentanyl presentation. We'll request that the mayor do a proclamation. Tivy Interact club will be asked to provide volunteer muscle for arrangements.
