RESOLUTION NO. 24-2025**

**A RESOLUTION AMENDING THE CITY OF KERRVILLE FEE
SCHEDULE BY REVISING VARIOUS FEES APPLICABLE TO THE
USE OF AND SERVICES PROVIDED BY THE CITY'S SCOTT
SCHREINER GOLF COURSE**

WHEREAS, City Council adopted a Fee Schedule by Resolution No. 91-138 on September 24, 1991, and has amended said document on a number of occasions; and

WHEREAS, over the past year, the City planned for and conducted comprehensive renovations of the Scott Schreiner Golf Course to enhance both the player experience and the course's long-term operational sustainability; and

WHEREAS, such renovations included the replacement of all greens and major upgrades to the cart paths and bridges; and improvements made to various course facilities such as the pro shop, restrooms, and the driving range; and

WHEREAS, in addition, the City sought a review by a third-party golf professional to guide the City in establishing a viable business model for the course, with the goal of generating sufficient revenue to cover ongoing operational and maintenance costs; and

WHEREAS, the proposed business model recommended that the City hire additional staff to ensure high-quality customer service and an enhanced golfing experience; and


WHEREAS, based upon the enhanced facilities, new staffing, and in an effort to sustain the long-term financial sustainability of golf course operations, City staff recommends that City Council approve increases to and the addition of various fees at the course; and

WHEREAS, City Council has determined it is in the public interest of the citizens of Kerrville to adopt the fees as provided herein;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF KERRVILLE, KERR COUNTY, TEXAS:**

City Council amends the Fee Schedule of the City of Kerrville, Texas, as set forth in **Exhibit A**, and attached and incorporated herein by reference, such changes to be effective immediately.


